

Information about preschool fees for 2023

The NSW government has changed the funding model for Preschool for 2023.

Families will be able to access fee relief AT ONE SERVICE to allow access to FREE PRESCHOOL for 15 hours (2 days) per week. If your child will be attending another service that offers fee relief (another community preschool or long day care service) you will need to choose which service you would like to receive fee relief from.

What do I have to do? For children enrolled at Deniliquin or Barham Preschool in 2023

If you want to claim fee relief (\$0 fee) you must

- 1. Complete the attached declaration form from the NSW Department of Education (to access \$0 daily fee)
- 2. Return the form to admin (admin@denichildrenscentre.com.au) by Friday December 2nd.
- 3. If you opt to receive Fee Relief at Deni Preschool- you will receive an invoice showing the fee relief amount.

If you opt NOT to receive the Fee relief at Deni or Barham Preschool

- 1. Complete the attached declaration form from the NSW Department of Education stating which service you are claiming fee relief at.
- 2. Return the form to admin (admin@denichildrenscentre.com.au) by Friday December 2nd.
- 3. You will receive an invoice for the first two weeks of fees which are <u>payable prior to your child starting preschool in</u> February.
- 4. If you are eligible for an Equity fee for your child, we must have <u>received EVIDENCE by Friday December 2nd</u>. This includes a Health Care Card, NDIS number or report/ assessment from a pediatrician.
